Proposal by shareholders on items to be discussed in the Meeting will be included in the agenda of the AGMS if the proposals have fulfilled the requirements stipulated in Article 10 paragraph 8 of Company's Articles of Association, Article 12 POJK No. 32/2014 and have been received in writing by the Company at least 7 (seven) days prior to AGMS Invitation date.

**PENGUMUMAN
RAPAT UMUM PEMEGANG SAHAM TAHUNAN ("RUPST")**

Merujuk pada ketentuan Pasal 10 ayat 2 Anggaran Dasar Perseroan dan Pasal 10 ayat 1 Peraturan Otoritas Jasa Keuangan No. 32/POJK.04/2014 tentang Rencana dan Penyelenggaraan Rapat Umum Pemegang Saham Perusahaan Terbuka ("POJK No. 32/2014"), dengan ini diumumkan kepada para pemegang saham Perseroan bahwa Perseroan akan menyelenggarakan RUPST pada hari **Kamis, 18 Mei 2017**, bertempat di Jakarta, Indonesia.

Setiap usulan dari pemegang saham akan dimasukkan dalam acara RUPST jika memenuhi persyaratan dalam Pasal 10 ayat 8 Anggaran Dasar Perseroan, Pasal 12 POJK No. 32/2014 dan harus sudah diterima oleh Direksi Perseroan selambat-lambatnya 7 (tujuh) hari sebelum tanggal panggilan RUPST.
